The Organisers have also given me the following information for you all :-

The rink is parquet floor (wood), 42 x 21 m, wheels recommended for **free skating are 49-53 and for dance 92-95**

Transfers from airport-hotel and hotel-airport are **NOT FREE**, all countries have to take care of their own transportation but if needed they can contact the Organisers for more information about the transfers, advising us of the arrival and/or departure time of their flights, how many people involved, flight details, after which they can advise you of the cost.

Extra officials on the teams will be charged 25 euros each and will have to be registered with the Organising office which is in the venue and payment made directly to them.

Extra training will be available after all registrations are completed and this will be without charge whatsoever, and will be arranged with the Organisers. This training will be at the same venue as the Competition.

Meals will be available in the venue, and menus, prices and reservation information will be released soon by the Organisers.

Please make sure that all registrations with the Organisers are made by 15 October at the latest.

If any Federation has problems with accommodation, or any other problems please contact the Organisers and they will do their best to help you.
